Uniform Officer Report

TeamZ have not gone out of business as noted in the last minutes. TeamZ is still able to order shirts jackets etc and apply embroidery as per past years. They have ceased manufacture of items such as Rash Vests, Competition singlets and caps. We were able to purchase competition singlets from TeamZ prior to ceasing production however we will need to purchase Rash Vests and competition caps prior to the start of the season. I have researched two alternate suppliers.

FashionFish – who currently supply our swimwear and hooded Towels. FashionFish are able to produce small quantities however the price increases for the small amounts.

Rash Vests (inclusive GST)

- 10 24 Units \$47.50 each
- 25 49 Units \$44.50 each
- 50 99 units \$41.50 each

Price includes current style – pink rash vest with black sleeves. Logo and Kiama Downs on front. Kiama Downs on the back.

Kozzi – minimum order is 50 items. They are currently promoting an early bird order - \$34.10 (inclusive GST)

Price includes current style – pink rash vest with black sleeves. Logo and Kiama Downs on front.

Both firms are able to supply a similar product to our current stock so the transition between suppliers should not affect current stock.

I propose we purchase 20 size 8, 20 size 10, 20 size 12 and 10 size 14 from Kozzi taking advantage of their early bird offer. Orders must be placed by the 1st June (although I may be able to get a couple of week extension). A 50% deposit would be required at the time or order. There will also be a \$40 set up fee payable which is a one off cost.

The cost of competition caps is the same for both companies. I would prefer to go with FashionFish as we have a standing business relationship.

All weather Jackets.

The current style of our All weather jacket is no longer being manufactured by Winning Spirit. However, Biz Collection make a very similar design which I feel would blend with any existing jackets. I have attached photos of old and new for comparison. If the committee agrees to proceed, I will ask Jason at TeamZ to quote on supply plus embroidery.





Dri Deck Parkas

Although I love the look of the Dri Deck parka and feel they would be ideal for the IRB I am concerned that we need to have a minimum order of 20 units @ \$150 per unit.

Unless the committee decides to purchase a large quantity of Dri Deck Parkas (for the IRB team/Nippers competitors for example) I do not feel it is worthwhile advertising them within our online store. This is due to the time it would take for the minimum order quantity to be reached.

In summary, can I please have approval to;

- Purchase 70 Rash Vests through Kozzi taking advantage of their early bird offer.
- Purchase 30 Competition caps from FashionFish
- Ask TeamZ to quote on the BIZ jacket.
- Dri Deck Parkas not to be advertised to club members. Hopefully, they will be purchased in bulk to supply our IRB team and/or nipper competitors at some stage in the future.
