Brett returned to chair the meeting and congratulated the new Committee.

Affiliation:

It is a requirement that the Club become affiliated with South Coast Branch.

Motion: That the Club affiliate with the South Coast Branch and that the fees are paid.

General Business:

1. Draft Budget was presented by Gary. It has been proposed that we replace the oldest of the two ATVs. BSEF grant to be applied for \$10,000. Difference is another \$10,000 for Club to spend on ATV. \$15,000 for balcony. \$5,000 for IT upgrade. \$10,000 for stairs. Proposed \$40,000 expenditure.

Questions from floor: Skip asked what the bank balances were: \$150,000 holding account, \$30,000 in running account and \$8,000 savings account. Skip said given the bank account balances he is happy with the expenditure.

Scott asked what the plans were for the decking out front of the building. Brett said discussions have taken place with Council and Fiona Phillips MP re funding and DA requirements. We need the DA before applying for grants. Will continue working on this after the Council elections. The Club is good at writing grants and we should move forward on this.

Bob asked if a new door in the radio room is part of the balcony upgrade as the door is in disrepair and Josh confirmed it is.

Jan asked about the proposed stairs on to the balcony and asked are we putting in additional funding for increased security. It was explained that there would be gates at top and bottom and security cameras and sensor lights. Bob questioned if stairs would be enclosed and this was confirmed that the design includes that a full wall be built and an enclosed area for bins be provided with no public access. General discussion took place. Jan raised how it is impossible to stop access to the Tower.

Josh confirmed that there will be a full wall with a solid door.

Motion: That the budget be accepted:

Brett asked if there was any urgent matters. Next meeting is end of September.

Jan said that she feels that she is the only one using the patrol tower and suggested if it is not being used, it could be donated to another club; moved to the southern end or alternatively take it seriously and have more resources in the tower and have more keys available. Bob mentioned that over summer the lifeguards use it. Skip said he struggles to use it and brief discussion took place about how to manage the

patrol members on the beach and in the tower. Archie commented that more resources in the tower would be needed if moved it south.

This matter is to be raised at the Patrol Captain's meeting prior to the new season.
